Calculation of connection charges for parcels of property which contain customers in more than one customer class shall be based on the pro rata proportion of building square footage used by each customer.

Notes and Definitions: When calculating capacity, the entire parcel area is included in calculation. All lands appurtenant to the premises, including parking areas incidental thereto shall be included.

BOD or Biochemical Oxygen Demand, is a measure of strength of sewage expressed in terms of the amount of oxygen required by bacteria to render swage inert.

SS or Suspended Solids are a measure of strength of sewage expressed in terms of quantity of solid material measured in milligrams within a liter of sewage.

HCF - Hundred Cubic Feet

Special Strength: \$5.02 per HCF

Commercial laundries, restaurants and bars with dining facilities, service stations with holding tank dumping facilities, car washes with auto steam cleaning facilities, bakeries and food processing, other commercial or industrial customers with concentrations greater than 200 milligrams per liter BOD or 265 milligrams per liter SS, but less than the concentrations of BOD and SS specified in Case-By-Case Classification.



Case-By-Case: the Sum of:

Flow	\$2,532.69 per MGD
BOD	\$375.62 per Thousand lbs.
SS	\$188.35 per Thousand lbs.

All commercial or industrial customers other than those with flows greater than .005 MGD, or with concentrations greater than 650 milligrams per liter BOD or 1,000 milligrams per liter SS; all intermittent customers; and any commercial or industrial customer requesting and paying the full cost of metering and testing.

Large Industrial: Contact the District for additional information on calculating charges. Industries with flows greater than 1 million gallons per day.

Regular Strength: \$3.11 per HCF

Offices, retail, stores, hotels, motels, schools, churches, hospitals, nursing homes, laundromats, dry cleaning establishments, bars without dining facilities, car washes without auto steam cleaning facilities, other commercial or industrial customers not included in Special Strength or Case-By-Case classifications.



Special Strength: \$5.16 per HCF

Commercial laundries, restaurants and bars with dining facilities, service stations with holding tank dumping facilities, car washes with auto steam cleaning facilities, bakeries and food processing, other commercial or industrial customers with concentrations greater than 200 milligrams per liter BOD or 265 milligrams per liter SS, but less than the concentrations of BOD and SS specified in Case-By-Case Classification.



Case-By-Case: the Sum of:

Flow	\$2,597.96 per MGD
BOD	\$401.90 per Thousand lbs.
SS	\$193.36 per Thousand lbs.

All commercial or industrial customers other than those with flows greater than .005 MGD, or with concentrations greater than 650 milligrams per liter BOD or 1,000 milligrams per liter SS; all intermittent customers; and any commercial or industrial customer requesting and paying the full cost of metering and testing.

Large Industrial: Contact the District for additional information on calculating charges. Industries with flows greater than 1 million gallons per day.
